REQUESTS FOR QUOTATION – 2024-06

ANNUAL PULVERIZE & PAVE

The Township of Nipigon is issuing this Request For Quotation (RFQ) to Pulverize & Pave a 150 meter (m) section of First Street from Front Street to Newton Street in Nipigon Ontario, Pulverize and Pave a 260 meter (m) section of Wadsworth Drive from Bell Street to the bottom of Wadsworth Drive hill & Pulverize and Pave a 140 meter (m) section of Greenmantle and Wadsworth Drive from 70 meters from the end of Greenmantle including the intersection of Greenmantle and Wadsworth Drive and 70 meters on Wadsworth drive.

Proposed Scope of Work

Contractor Name (Please print on each Pages):

To Pulverize & Pave approximately 150 m of First Street, 260 m on Wadsworth Drive & 140 m of Greenmantle and Wadsworth drive including the intersection. The width is on average 7.0 m and the thickness of the asphalt to be placed is 50 mm of SP 12.5. It is anticipated that there will be a minimum of a 2% crown in the new asphalt. It is anticipated that there will be a +/- One (1) month delay between pulverizing and being ready to place the asphalt. After pulverizing the Township intends to make a base repair with internal forces. Contractors should anticipate separate mobilizations for the pulverizing and the paving.

Contractors are asked to provide a price for SP 12.5 and specify if 1 lift or 2. It is anticipated that the Contractor will pulverize in one (1) mobilization and demobilization; and, at a later date pave in a second mobilization and demobilization. It is expected that the successful Contractor will complete a "walk through" of the site to confirm adequacy of base prior to paving. Anticipated schedule:
